3. A DUPLICATE COPY OF MIGRATION CERTIFICATE can be issued against a fresh Fee of Rs:500/-(Normal Fee) while Urgent Fee Rs:700. Provided that the application is accompanied with an AFFIDAVIT of the candidate duly attested by a MAGISTRATE FIRST CLASS stating that the Original Migration Certificate issued by the BOARD has been lost and was not used for any other purpose and cutting of ADVERTISEMENT IN TWO NEWSPAPERS.

4. Application for Migration Certificate must be forwarded through the HEAD OF INSTITUTION LAST ATTENDED.

5. Migration Fee must be deposited with the nearest branch of ABL/UBL/P.O in Malakand Division.

6. At the time of submission of Migration Application Form, the applicant who passed/failed last SSC/HSSC examination after a lapse of one year or more is required to accompany an affidavit duly attested by Oath Commissioner and countersigned by first class Magistrate to the effect that he has neither take of admission in any institution as a regular student is applied for such migration.
